**DESCRIPTION:** 6 people will enjoy 5 days/ 4 nights accommodations at “Las Golondrinas” Villa Cayuco 33, a privately owned, multi-million luxury villa situated between the Punta Espada and Las Iguanas Golf Courses in Cap Cana, Dominican Republic. Designed by Jack Nicklaus, Punta Espada is the number one rated course in the Caribbean. The luxurious villa has 5 BR (auction package includes 3 BR-2 additional bedrooms will be locked, but they can be available at an additional cost if desired) and 6.5 baths, dining and recreational open air pavilion, full kitchen, hot tub and pool with pristine views. Bedrooms are stunningly appointed, fully air-conditioned with en suite bathrooms including soaking tub and indoor or outdoor showers! Package includes airport transfer for 6 people to/from Punta Cana Airport (PUJ), the services of a private chef/butler, maid, and concierge. The villa will be stocked with food and beverage to your specifications\* (\*At additional cost.) and prepared by the private chef. Also included is one evening of private poolside merengue, salsa and bachata dance lessons for the group. The package expires one year from the date of the event and excludes air travel from the US, \$10pp airport visa fee upon arrival, gratuities and costs/activities not mentioned. Additional nights and guests can be added post event.

Reservations are subject to availability. (It is suggested all bookings be made at least 90 days prior to travel.) Blackout dates of December 17 through January 7 apply. High season surcharge applies for Easter week and Spring Break week. In response to the COVID-19 emergency, the expiry date is extended to two years. This will be adjusted if necessary.

- The organization agrees to pay a reserve price within 14 days post event (ONLY IF SOLD—there is no pre-payment nor obligation if it does not sell.) Any proceeds above the reserve price go to the organization/foundation.
- The organization agrees to provide Auction Shake Up with name, phone and email address of the successful bidder(s) within 72 hours after the close of the event. An invoice will be provided post-event for tax and accounting purposes. This invoice number becomes the tracking number for the winners, post event to validate their certificate and use in booking communications. No travel dates can be confirmed until the reserve monies have been received.
- A certificate, winner packet, event brochure and slide show shall be provided for use in marketing the package. The winner must be given the provided certificate/winner packet which includes the instructions on how to obtain a tracking number and proceed with the booking process.
- If the committee, board, or auctioneer have questions not answered in the materials, Beth can be available individually at any time on the cell or via speaker phone to the group. (For group calls, please give 24+ hours notice if possible.) I can also be available to be present at your event to help encourage the bidding and promote the trip(s). Contact me for details.
